AND

Partner 2: Vaish Arya Shikshan Mahila Mahavidyalaya (VASMM), Bahadurgarh, Haryana through its Principal Dr. Smt. Asha Sharma.

Background: There has been academic association and cooperation between D. P. B. Dayanand College of Education, Solapur & Vaish Arya Shikshan Mahila Mahavidyalaya, Bahadurgarh, Haryana through telephonic and online interaction between the Principals and the Management. Both the Colleges are teacher Education Colleges, recognized by NCTE and cater to the educational needs of society in their respective regions by providing professionally prepared teachers institutions at various levels. Responsibilities: Both the colleges will work and contribute in online / offline mode as per suitability and cooperate each other for fulfilling the objects of MoU.

- 1. The D. P. B. Dayanand College of Education will cooperate / guide the Vaish Arya Shikshan Mahila Mahavidyalaya, Bahadurgarh, Haryana for:
 - a) Organization of Special lectures on academic issues
 - b) Staff development matters
 - c) Sharing Teachers' expertise on academic matters
 - d) Enable students of VASMM in organizing special activities such as Personality Development, Leadership Development, Positivity, Nurturing Creativity, Interview Techniques workshop, Mind Power, etc.
 - e) Sharing students' and teachers' resources for exhibitions, contests, competitions, social network for institutional and social development.
 - f) Organization of courses/ certificate courses / cafeteria courses / short term courses/ Diploma Development of Teaching Competence, ICT Proficiency for Teaching and non teaching faculty of the college.
 - g) Participation in and consultation for IQAC of VASMM.
 - h) Any other pertinent topic/ issue/ activity of interest of the VASMM.
- 2. The Vaish Arya Shikshan Mahila Mahavidyalaya, Bahadurgarh, Haryana will cooperate / guide for the D. P. B. Dayanand College of Education for:
 - a) Organization of Special lectures on academic issues
 - b) Staff development matters
 - c) Sharing Teachers' expertise on academic matters
 - d) Guiding D. P. B. Dayanand College of Education on spreading awareness on various social issues such as Environment Conservation, Save Girl Child, Women Empowerment etc.
 - e) Participation in and consultation for IQAC of D. P. B. Dayanand College of Education.
 - f) Any other pertinent topic/issue/ activity of interest of the D. P. B. Dayanand College of Education.
- 3. The two colleges may organize activities and programs either in common or separate as per situation and their convenience.

Funding:

- a) If an activity is organized for the interest of both the colleges, the expenses will be shared on 50:50 percent basis and the income / financial resources, if at all any generated, will be shared on equal basis or mutual understanding.
- b) If any programme / activity / course is organized in the interest of a single college alone, that college will bear the responsibility of the expenses.

- c) Resources / staff resources when shared by a college for the other college may not be remunerated if there is no such financial provision.
- d) There will be mutual understanding between the two colleges on financial matters.

Reporting:Reporting to each other as well as to media, if at all any, will be done by the IQAC coordinators / members of the respective Colleges. A record of activities will be maintained by both the colleges and this will be the responsibility of the Principals to get it done in the respective colleges, rightly in the spirit of cooperation and sustenance of this MoU.
